Sir/Madam,

Please refer to your letter dated 07.05.2009.

In this regard, it is to inform you that as per clause 10(1) of NCTE Regulations 2007, "In the case of self financed institutions including Government/Government aided institutions running a course on self-financing basis, there shall be an endowment fund of Rs.5.00 lakhs per course per unit and a reserve fund of Rs.3.00 lakhs per course per unit of approved intake, in the form of a Fixed Deposit of a duration of and above 5 years of a nationalized bank. The endowment fund and reserve fund shall be operated jointly by the authorized representative of the management and an officer of the Regional Committee concerned."

Therefore, you are kindly requested to submit original FDRs of Rs.5.00 lakhs and Rs.3.00 lakhs for each intake of 50 students for B.P.ED. course and FDRs of Rs.5.00 lakhs and Rs.3.00 lakhs for each intake of 30 students for M.P.ED. course within 30 days from the date of issue of this letter.

Your letter of continuation of recognition will be issued after the receipt of original FDRs and consideration of PARs by WRC.

CONTINUATION ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely PEOPLE'S EDUCATION SOCIETY'S P.E.S. COLLEGE OF PHYSICAL EDUCATION, NAGSENVANA, CANTT. AURANGABAD, MAHARASHTRA vide order No. WRC/5-6/2K/11338-342 dated: 14.12.2000 for conducting B.P.Ed. course with an annual intake of 60 students.

2. AND WHEREAS, the Revised Recognition order was issued to the institution vide dated 31.05.2015 for B.P.Ed. course with an annual intake of 100 students with a direction to submit the compliance to the Revised Recognition order on or before 31.05.2015.

3. As no compliance to the revised recognition order was received, the matter was considered by WRC in its 255th meeting and as per the decision of WRC, Show Cause Notice for non-submission of compliance was issued vide dated: 03.10.2016 and reply submitted on 21.10.2016

4. AND WHEREAS, the matter was considered by WRC in its 292nd meeting, wherein the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.

Accordingly, withdrawal order was issued to the Institution on 02.08.2018.

5. AND WHEREAS, the Institution filed an appeal to the Appellate Authority Hqs. And the Appellate Authority vide order dated 27.08.2019 remanded back the case to WRC.

6. AND WHEREAS, the institution has submitted the compliance dt. 30.08.2019 in pursuance of appeal order, which was considered by WRC in its 313th meeting, held on 25th to 27th February 2020 wherein the committee decided to issue the Show Cause Notice to the Institution.

Accordingly, Show Cause Notice was issued to the Institution on 09.03.2020.

7. AND WHEREAS, the Institution has submitted the compliance dt. 25/08/2020 in pursuance of Show Cause Notice, which was considered by WRC in its 314th meeting held on 13th - 15th and 22nd July 2020, wherein the committee decided to give the last opportunity to the Institution.

Accordingly, Final Show Cause Notice was issued to the Institution on 06.08.2020.

8. AND WHEREAS, the Institution has submitted the compliance dt. 09.09.2020 in pursuance of Final Show Cause Notice, which was considered by WRC in its 317th meeting held on 28th - 30th September 2020, wherein the committee decided to give the last opportunity to the Institution.

Accordingly, Final Show Cause Notice was issued to the Institution on 13.10.2020.

9. AND WHEREAS, the institution has submitted the compliance dt. 03.11.2020 in pursuance of Final Show Cause Notice, which was considered by WRC in its 322nd meeting held on 23rd to 24th November 2020 wherein the committee decided as under.

The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under.

Recognition of the institution be continued for the B.P.Ed. programme with an intake of one unit of students from the date of order.

10. NOW THEREFORE, the recognition granted to the Institution for conducting B.P.Ed. course has been continued as per decision of the WRC in its 322nd meeting from the date of this order.

11. The institution shall continuously adhere the NCTE Regulations, 2014 as amended time to time and any deviation from it shall be liable for action, against the Institution, as stipulated under NCTE Act, Rules and NCTE Regulations.
